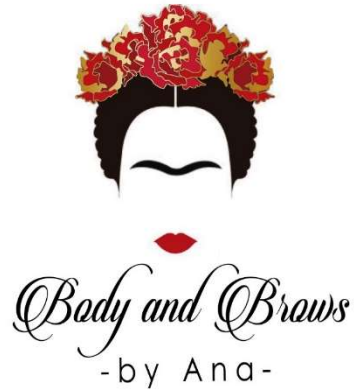

Please read the following statement carefully:

- Ombé, Nano, Combo (Hybrid) Brows and Lip Blush are each a way of cosmetic tattooing, all requiring a touch-up session
- A healing period of 8-10 weeks is required before a touch-up procedure can be performed
- On a rare occasion, the pigment may migrate under skin
- The procedure may be uncomfortable
- Immediately after the procedure, the pigment can appear 30-50% darker than the desired results
- Although extremely rare, there might be an immediate or delayed reaction to pigment – a negative patch test result does not guarantee you will not develop an allergic reaction after the full procedure
- Allergic reactions to anesthetic can occur
- **Permanent cosmetics cannot be applied to pregnant women or nursing mothers**
- **Permanent cosmetics cannot be applied to any person under the age of 18**
- Infections can occur if after instructions are not followed correctly
- There may be swelling and redness following the procedure – you may experience minor bleeding during procedure
- If you have an MRI scan within 3 months after your procedure, you should notify/discuss with your doctor
- Scarring is extremely rare, but may occur
- The pigments will fade, depending upon your skin cycle

Please read this form fully and sign at the end. If you are unsure about a particular detail of the form, please speak to your technician for clarification.

- If unforeseen condition arises in the course of PMU/SPMU procedure, **I AUTHORIZE** my doctor to use their professional opinion to decide on what he/she feels necessary in the given circumstances.
- **I ACCEPT** the responsibility for determining the color, shape and position of the PMU/SPMU procedure as agreed during consultation.
- I understand that an allergy test, does not guarantee that I will not develop an allergic reaction to the pigment. I fully understand and accept that non-toxic pigments are during the procedure and that the result achieved may fade over a period of 1-3 years – even once the color will fade, pigment itself may stay in the skin indefinitely.

I have been informed that highest standards of hygiene are met and that sterile, disposable needles and pigment containers are used for each individual client, procedure and visit.

I understand and accept that each procedure is a process requiring more than one session to achieve desired results, and that the *final result cannot be expected during the first procedure*. I understand that will have to return for a touch-up session to complete the process.

Initial

The results of the procedure are determined by the following: medication, skin characteristics (dry, oily, sun damaged, thick or thin skin types), personal pH balance of your skin, alcohol intake and smoking, post procedure aftercare:

- Upon completion of the procedure there might be swelling and redness of the skin, which will subside between 1-4 days. In some cases, bruising may occur. You may resume your normal activities following the procedure, however, using cosmetics, excessive perspiration and exposure of the sun should be limited until the skin has full healed. Please see aftercare card for more details. You can be assured that the procedure results will look acceptable for you to appear in public without additional makeup on the affected area.
- I have been advised that the true color will be seen 1 month after each procedure, and that the pigment may vary according to skin tones, skin type, age, and skin condition. I understand that some skin types accept pigment more readily and no guarantee on exact color can be given.
- To my knowledge, I do not have any physical, mental, or medical impairment or disability that may affect my well-being as a direct or indirect result of my decision to have the procedure done at this time.
- I agree to follow all post-procedure instructions as provided and explained to me by the technician.
- I hereby release any and all responsibility. I accept any and all responsibility myself for any consequences that may stem from my decision to have any permanent cosmetics procedure performed by the Body and Brows by Ana Technician.

Please read the following statement carefully regarding healing process:

- The healing process requires commitment from the client to follow healing protocols and stay away from regiments that could interfere with obtaining the desired appearance
- I understand that to achieve the best result I must be willing to follow the healing guidelines given to me below
- Touch-up session for Ombré, Nano, Combo (Hybrid) Brows and Lip Blush should be scheduled within 8-10 weeks after the first session
- I understand that touch-ups will **not** be scheduled before the 8-week required healing time.
- I understand that I may, and will most likely experience scabbing, patchiness, and color fading **40-90%** during this 8-week healing process. This is the normal part of the healing process and I should not try to pick scabs or cover up with personal regiment
- I understand that applying makeup to treated area will cause the healed result to be less than desirable.
- I understand Ombré, Nano, Combo (Hybrid) Brows and Lip Blush are each a two treatment procedure
- I understand that if I decide not to have a touch-up within 8-10 weeks, my cost for the touch-up session will increase
- I understand that if I decide to have a facial, laser treatment or any other spa related services immediately after or during healing the process that the results may not be best
- I understand that if I go out into the sun, pool and/or beach that there will be a significant amount of fading.

Touch-Up (2nd Session) Pricing:

- Within 8-10 weeks of initial session, \$250 for Ana, \$200 for Angie
- If you miss the 10 week mark, the touch-up is \$275
- After 6 months, it is \$375
- After 1 year, you will need to start over and book a new service.
- **All touch-up appointments cancelled or rescheduled within 48 hours of the appointment time will result in the forfeiture of reservation fee (AKA the 50% booking deposit)**

Yearly Touch-up

A yearly touch-up is for a client who has already completed the full procedure (1st & 2nd Session) and after a year would like to get a fresh color boost or go darker and bolder. The price for yearly touch-up rate can vary or change based on what the artist is charging at that time. If you DID NOT have your initial (2nd session) touch-up after your first session, a yearly touch-up rate will not apply to you and your rate is stated above under Touch-Up (2nd Session) Pricing.

Yearly touch-ups are NOT required as some clients enjoy their brows as they fade over 3 years.

Body and Brows by Ana has built its business on realistic expectations, transparency, as well as concerns the client must know about that other salons and artist usually do not disclose. There are many artist in this field who tend to mislead the public through unrealistic claims such as end result, retention, and longevity, and photos that have been grossly edited for promotion.

Although almost all of our clients walk away extremely happy with gorgeous brows and/or lips, we are not the “one for all” solution. We post beautiful results of our clients on social media but in no way does this guarantee you will receive the same healed result. On some occasion we do encounter clients with certain skin types that cannot be identified by simple examination that causes the desired result to fall short. As with any cosmetic procedure with any medical doctor, facial specialist, or tattoo artist, there are never guarantees for result as everyone’s skin is different.

Body and Brows by Ana LLC and its artists will make recommendations and present pictures of past clients we however will NOT guarantee a final result of any kind.

Being that Ombé, Nano, Combo (Hybrid) Brows and Lip Blush are semi-permanent and fade over a period of time (based on past results), there are some cases where a person could have skin that does not accept pigment or might have one or more small areas of the treated area that will not retain pigment.

These reasons are usually due to oily skin, scars, moles, skin tags, skin cycles, or even lifestyle activities including excessive sweating, extended sun exposure to skin, facial or chemical peels on the treated area, including unforeseen issues not listed here.

We always let you approve the outlines and shapes (pre-draw) of your brows and when the procedure is finished we let you approve everything before departure so that we can make any corrections before you leave. Although we strive for 100% satisfaction, we can never make guarantees that your skin will take well with the procedure or be compatible.

For this reason, Body and Brows by Ana LLC does not offer refunds or guarantee results.

By signing, I understand that there are no refunds for any payments including booking deposits or payments for the balance of the service and will not hold Body and Brows by Ana LLC responsible for chargebacks.
